Note: The information contained in the analysis synthesizes public information contained in news articles, election analysis publications, and polling information, such as the California Target Book, Ballotpedia, CalMatters, the California Secretary of State, and official candidate campaign websites.



## BACKGROUND

---

The General Election will take place on November 5, 2024. California voters will choose representatives for all of California's seats in the U.S. House of Representatives, one U.S. Senate seat, all seats in the California Assembly, and 20 California State Senate Seats. Californians will also participate in the national 2024 presidential election, and they will determine the outcome of 10 ballot measures, which include 2 bond issues and 3 constitutional amendments.

## PRESIDENTIAL ELECTION YEAR:

---

On July 21, 2024, President Joe Biden withdrew from his re-election bid and endorsed Vice President Kamala Harris to succeed him. Vice President Harris accepted the Democratic presidential nomination on August 22nd and will go up against former President Donald Trump. In Congress, California is a crucial battleground this election with 6 swing districts that are vital in determining which party will control the U.S. House of Representatives next year.

## LEGISLATIVE RACES:

---

This memorandum outlines the candidates running in open seats in the California State Assembly and Senate in the November election. There are 36 legislators this year who are either termed out of office, running for different offices, or are leaving the California Legislature entirely. There are 24 legislators leaving the Assembly and 12 leaving the Senate. Next year's legislative freshman class will represent 1/4th of the California Legislature.

Republican Bakersfield City Councilmember Ken Weir took second place in the Primary Election with a write-in campaign and will appear on the November ballot. Vince Fong echoed to his supporters that he is not running for re-election to his Assembly seat and endorsed Weir to succeed him.





### PROPOSITION 2

Authorizes Bonds for Public School and Community College Facilities

Authorizes \$10 billion in general obligation bonds for repair, upgrade, and construction of facilities at K-12 public schools (including charter schools), community colleges, and career technical education programs, including for improvement of health and safety conditions and classroom upgrades. Requires annual audits.

**Fiscal Impact:** Increased state costs of about \$500 million annually for 35 years to repay the bond.
