MINUTES OF THE

November 18, 2024 at 9:30 AM

1. CALL TO ORDER

The Western Municipal Water District (Western Water) Finance Committee Meeting of the Whole was called to order by Director Mike Gardner at 9:31 a.m., in the Training Room at the Western Water Headquarters Office, 14205 Meridian Parkway, Riverside, California.

A. Quarterly Investment Report for the Period Ended September 30, 2024

Dan Delaney, Chandler Asset Management, presented the quarterly investment report for the period ending September 30, 2024. He discussed factors that can affect investment results, including employment the GDP, the economy in general and inflation. He reported that the higher interest rates have not had as much impact as anticipated and talk of a recession had ended. He noted that the Federal Reserve had cut rates twice and the official interest rate is currently 4.75%. He discussed Western Water's decision to issue a larger amount of debt when the rates were low, so we will not be greatly affected by the rate fluctuations. He noted that bond yields had a very good third quarter, causing increased earning for Western Water. He reported that Western Water is in full compliance with our policies and reviewed our account profile. He finished by reviewing Western Water's VEBA Trust, again noting we are in full compliance and he reviewed the current asset allocation and remarking that our investments have a good diversification.

A. GENERAL MANAGER REPORT

General Manager Craig Miller announced that there may be an added item to the Board Meeting agenda on Wednesday, November 20, 2024. He stated that depending on the outcome of a vote at the Metropolitan Water District Board Meeting, Western Water will bring an item to be added to the agenda to possibly make an investment to pre-purchase water pursuant to a reverse cyclic program. He said he felt this would be a great financial opportunity for Western Water to be able to purchase water at a lower rate now for delivery in the future.

B. CHIEF FINANCIAL OFFICER REPORT

Assistant General Manager/Chief Financial Officer Kevin Mascaro, reported that TD Bank, a firm Western Water does business with and where we have our pipeline replacement line of credit has been downgraded by the S & P, as a result of fines and civil and criminal penalties they bank received due to a money laundering incident. He provided brief information about how this may affect Western Water and stated that although we will monitor the situation closely, he felt this was an isolated incident and that the group we have our line of credit with is still credible.
